REPORT OF THE PRESIDENT:

President Carter asked for reports from each division.

Dr. Lyman, Provost and Executive Vice President, called attention to the following information from Academic Affairs:

Dr. Lyman also reported on recent faculty accomplishments.

Dr. Roger Serr, Vice President for Student Affairs, announced that Field Hockey was 2-1 in the NCAA playoffs. They are currently playing and winning.

Ms. Fawks, Associate Vice President for Administration and Finance, presented items of interest and asked for appropriate action by the Council.

Upon a motion of Mr. Shoemaker, seconded by Mr. Schaul, the Council approved Purchases and Contracts, as made under the provisions of Act 188 and shown as MINUTES ATTACHMENT 1 & 2 respectively.

Representatives from CliftonLarsonAllen conducted an audit of Financial Statements and Supplementary Information for Years Ended June 30, 2017 and 2016. An unmodified opinion clean audit, no issues was issued. Upon a motion of Mr. Redding, seconded by Mr. Ross, the findings were approved.

Upon a motion of Mr. Grell, seconded by Mr. Redding, the Council approved a Resolution, which certifies that all affiliated organizations are in compliance with the Board of Governors policy 1985-04-A, as shown as MINUTES ATTACHMENT 3.

Dr. Topper, Associate Vice President for Administration & Finance, call attention to recent non-instructional personnel actions.

Dr. Kim Garris, Associate Vice President for External Relations, reported short-term projects such as get more student marketing and the use of alumni. A new video content producer for the web and social media and Sports Information has been working on high level games. Long term – strategic plan for messaging for the university and recruitment; and social media follow ship has been robust this semester.

Dr. David Lovett, Interim Vice President for Enrollment Management & Student Success, reported on the following items: expecting a large Open House group tomorrow; uptick in

number of students & parents visiting since August; approximately 300 Raider Success scholarships have been awarded as a recruitment tool; College Day has been instituted to embrace our local schools up/down 81 and east/west to bring students to campus - traveling east to west to provide information on the opportunities and why they should come to Ship.

PRESIDENT'S REPORT:

President Carter announced that the System has identified three strategic priorities, in response to NCHEMS. They are: 1) ensuring student success, 2) leveraging university strengths, and 3) transforming the leadership/governance structure. They also passed a Resolution for long-term sustainability for the universities.

There has been a smooth transition with the SU Foundation. John Clinton has retired and we look forward to a continued strong foundation with them.

Dr. Dave Lovett will serve as Interim Vice President for Enrollment Management & Student Success. Dr. Lovett has served SU for many years and is well-equipped to take on this role. Thank you to Dr. Ruth for stepping up to fill the gap.

A recent Enrollment Retreat was held in which 50 members of faculty, staff, & students participated to discuss strategies to move the University forward.

COMMENTS FROM THE ALUMNI ASSOCIATION:
