Dr. Roger Serr, Vice President for Student Affairs reported on GPA's of our student athletes. Of the 18 teams, consisting of 470 athletes, the average GPA for Fall was 2.98. There are 11 teams with a 3.0 or higher; 24 students with a 4.0; and 146 with a 3.5. Our athletes really are student-athletes.

Attention was called to recent non-instructional personnel actions.

Dr. Folmer Clinton, Vice President for External & University Relations reported that the Luhrs Center mid-season brochure was available and 3 new shows were added. ZZ Top is already sold out. In addition, The H.O.P.E. Scholarship speaker this year is BD Wong; and two new hires within Communications & Marketing – Megan Silverstrim is the Media Relations/Social Media Manager; and Perry Mattern is the Assistant Sports Information Director.

Dr. Lyman announced that SU has been awarded a portion of federal grant funding under the Eligible Partnership Grant Program. Governor Wolf announced Ship's nearly \$1 million award for its Learning to Lead Urban Leadership Residency Program. Four school districts will participate in the program, with a total of 24 teachers, from Harrisburg, Steelton-Highspire, York City, and Reading school districts. Dr. Jerry Fowler is the grant director, assisted by Dr. Jennifer Pyles and Dr. Phil Diller.

COMMENTS FROM THE ALUMNI ASSOCIATION:

Mr. Harbach stated that Shippensburg University has an alumni base of 67,000 current/living alumni in five states have the highest numbers: Pennsylvania – 41,000; Maryland – 2800; Virginia – 1500; New Jersey – 1300; and Florida – 1100. Mr. Harbach also reported on the following: alumni will be hosting a Hospitality Suite in the Heritage Center at Chambersburg IceFest from 11:30-1:30 tomorrow; February 18 will be the first ShipMates event for alums who met on campus; pilot job shadowing program with 21 different opportunities in the field of business during spring break; alumni weekend is June 1-4 with golf proceeds going to the Legacy Scholarship; and accepting nominations for the alumni board by February 1.

Mr. Ross inquired about opportunities for our students to have assistance with transition from student to life as they leave school. Mr. Harbach stated that there is a boot camp to help with resumes. The Alumni Office works with Career Development to help students with such and the boot camp is evolving. Dr. Laskowski stated that faculty would accept alumni to assist in Capstone courses and maintain contact with former students. Drs. Serr & Clinton will look into this further.
